This statement is submitted to you following the adoption by European authorities of the General Data Protection Regulation of the 27th of April 2016 on the protection of private individuals regarding the processing of personal data and the free movement of said data (here-after called GDPR).

What are personal data?

Will your data be shared with other organisations?

How long will your data be conserved?

Your personal data will be kept for a duration necessary to the achievement of the objectives of their processing.

Beyond that period, your data will be kept for a variable duration depending on the type of processing, as described in our processing activities register.

What rights do you have regarding the processing of your personal data?

The GDPR recognises a series of rights to the people whose data are processed.

Your rights related to the processing by INFOREF of your data are the following:

- Right of information (= right to be notified when personal data about you are collected)
- Right of access (= right to ask whether data about you are collected and to obtain such data)
- Right to rectification (= right to ask your data be rectified or completed)
- Right to erasure (= right to require that your data be erased as soon as possible)
- Right to processing limitation;
- Right to data transferability (= right to receive data in a structured, commonly used format, legible by a machine)
- Right to contest (= right to contest private data processing)
- Right to contest any automated decision-making
- Right to be notified of a personal data breach (= the data controller is under obligation to notify the person concerned by data breaches)

These rights can be applied, free of charge, sending a dated and signed request with a copy of your ID card to the person responsible for data processing at the address: securite.donnees@inforef.be.

If the conditions for right exertion, decreed by the GDPR, are met, INFOREF will grant your request and proceed to the necessary operations.
